Bristol Corn Trade Guild minutes of the Annual General Meeting held on Thursday 11th May 2023 at Junction 24, Sedgemoor Auction Centre, Market Way, North Petherton, Somerset TA6 6DF

Present:

Chairman of the Meeting: Daniel Hughes, Vice-President and 63 Guild Members. The minutes taken by Victoria Bywater, Secretary BCFTA

Apologies:

Daniel Hughes welcomed members to the Annual meeting of the Bristol Corn Trade Guild.

Daniel Hughes confirmed apologies had been received from Neil Chapman, President, Richard Cooksley Honorary Secretary & Honorary Treasurer and from 12 members.

1: Convening Notice

Daniel Hughes confirmed that the notice convening the meeting had been sent to all members informing them that the Annual General Meeting of the Bristol Corn Trade Guild would take place on Thursday 11th May 2023.

2: Obituaries

Daniel Hughes reported to the meeting that Mike Fairey, Dorothy King and Brian Williams had passed away since the last AGM.

3: Approval of Minutes of the AGM held on 17th May 2022

It was proposed by Dave Stanford and seconded by Ian Eastwood that the minutes of the last AGM held on the 17th May 2022 should be accepted which was unanimously approved.

4: One Hundred and Twenty Third Annual Report & Accounts

Daniel Hughes confirmed that the annual Executive Committee report was enclosed within the financial report produced by Bishop Fleming and that the accounts had been approved by the Executive Committee.

Daniel Hughes further reported the following:

- a. It has Charitable funds of £310,294 at the end of 2022 of which £275,463 was held as investments, which are subject to changes according to market conditions
- b. Charitable Grants of £6,800 were given in 2022 which is an increase of £1,700 over the previous year

Daniel Hughes confirmed that the Guild looks to members of the trade and the BCFTA to act as eyes and ears to make the Guild aware of potential individuals to assist giving financial and emotional support.

Daniel Hughes read aloud an email received recently from a beneficiary (the details of the beneficiary were anonymised).
